ARTICLES OF INCORPORATION & BY LAW CHANGES ----

A committee consisting of Larry Pease, Dick King, Jim Key, Hank Thomas & Brooke Armat as legal mentor incorporated changes and made revisions required to update the PVS constitution.

By request of the EX COM the 5th Article of Incorporation was changed to include a fourth class of membership. Non skiing spouse members who shall be the marital partners of active members.

The following are revisions to the By-Laws.

SECTION I - Membership

- A. Members of this club who joined before December 31, 1965, are termed charter members.
  - B. An applicant for membership must:
    - 2. Attend at least two meetings of the club by invitation of his sponsor.
    - 4. Have skied three days, not necessarily consecutive, in the company of three or more members.
- E. In the event an applicant is delayed in meeting membership requirements, the Executive Committee, if otherwise convinced of an applicant's qualification for membership, may direct the Membership Committee to present his name, along with the Committee's recommendation, to the membership for approval. (This replaces original E) ORIGINAL F. & G. retained intact.

SECTION III - Finance

- P. dues for absentee Spouse changed to \$4.00 SECTION III Government and Elections
- B. The President and three members of the Executive Committee shall be elected by a majority vote of the active membership present and voting at the annual April meeting. The term of a member of the Executive Committee shall be two years.
- C. The immediate past president is Ex Officio a non voting member of the Executive Committee for one year.

Former C. changed to D. Drop old section D.

F. A vacancy in the Executive Committee shall be filled by appointment by a majori vote of the remaining members of the Executive Committee and the appointed member shall serve the unexpired term.

H. Nominations: The President shall appoint a Nominating Committee Chairman and a Committee of no less than five (5) additional members, at least three (3) months prior to the election date, which Committee shall place in nomination names of candidat at a business meeting not later than two (2) months prior to the election. Prior to that meeting, notice of the Committee's nominations shall be mailed to every active members. Additional nominations may be made by signature of any five (5) active members in good standing and must be presented at a business meeting at least one (1) month prior to the election.

Section IV Duties of Officers:

- C. at end of introductory sentence, change "procedures" to "responsibilities".
- D. Add: "Four members of the Executive Committee constitute a quorum.
- E. In the first sentence, insert "standing" before "Committee chairmen." Change last sentence to read "Each chairman shall designate an assistant and select such additional committee members as he deems necessary.

The committee proposes these revisions to the members as necessary to clarify the By-Laws and to comply with the requests of the EX COM. It would be appreciated by the committee if members would study the changes and be prepared to vote their acceptance at the next meeting. Upon acceptance they will be printed and mailed to individual members. As a change has been made to the Article of Incorporation, Brooke Armat will be required to present the revised Articles to the Board in Washington.
