It was to be an alternative to the unattractive aspects of large size clubs. Where are we? We have slowly grown to a club of 88 members. Our turnover reate is quite small. Stagnation is our problem. Very little new blood comes our way and old blood tends to stay out of the limelight. It is a chicken and egg situation. Without active participating members, there is little to intice new members. Without new blood, one of two choices exists: The old blood must continue to recycle itself and keep the club active; or, just let the club slip slowly into an inactive status. I think there are warning signs of the latter. I am also quite sure that none of us individually want that to happen. So folks, it's up to you, the membership. Where do we go from here? The answer is yours to make.

Drop Carol a line and learn what the skiing conditions are in New England??? "HOW TO BECOME CLASSIFIED COMPETITOR (ALPINE) AND ENTER SANCTIONED RACES, EASTER./USS

1. You must be a currently paid up member of the Eastern Ski Association, 22 High St P.O. Box 727, Brattletoro, Verment 05301. Dues through a 100% Club (all members of the club automatically belong to Eastern) are  $\frac{5}{1}$  Individual and  $\frac{10}{\text{Family}}$ . Dues through an Active Club (15/more members) are  $\frac{10}{1}$  Individual and  $\frac{20}{\text{Family}}$ , with rebate to the Club at the end of the year of  $\frac{2}{1}$  Individual and  $\frac{4}{20}$  Family. Unattached (belong directly to Eastern without any club affiliation) dues are  $\frac{100}{1}$  Individual and  $\frac{420}{20}$  Family. (All new Clubs pay initiation fee of  $\frac{425}{20}$  -- except 100% Clubs; non-100% Clubs pay annual dues of  $\frac{10}{20}$ .) All new members -- in whatever category -- must have a completely filled out Eastern membership application form accompany dues.

2. Classification fees must be paid by those individuals who wish to race in Sanctioned Races (Eastern/USSA). The individual must stipulate the classification he/she seeks -- whether Junior, Senior, Veteran or both Senior & Vets and pay proper amount. Seniors (must be over 18 years of age) are classified according to ability levels (A,B,C,D) determined by Seeding Points earned by the competitor -- one starts at the "D" level. Veterans (must be 27 years of age and over) are classified by age groups as are Juniors (must be 18 years and under) and race accordingly. <u>Birthdate</u> is mandatory for all competitors.

<u>Classification Fee Chart:</u> <u>Senior A - \$15.00 (Seniors must be over</u> B - \$10.00 18 years of age)	Veterans I-V - \$10.00 (Vets must be 27 years and older)
C - \$10.00	Vet I - 27-31 years of age VetII - 32-39 years of age
D - \$ 5.00	VetIII- 40-47 years of age
Juniors I & II (18-14 years) - \$10.00	VetIV - 48-55 years of age Vet V - 56 years of age/older

(Combined Senior and Veterans Fee - Pay higher of the two fees - example: Senior D and Veteran Fee pay \$10.00 for both and check both categories (must be over 27 years to race in both categories).

(Juniors are described as 18 and under as of March 31st or 19 years as of March 31st and a Senior in High School - for one year only).

<u>Membership/Classification Card</u> will be sent each competitor, carrying an Eastern # in 6 digits. Keep your card with you at all times as you may be asked to show it!

Entry Vouchers (36 in number and personalized in magnetically coded ink) will be sent to all Senior, Veteran and Junior I & II competitors. Safeguard these as they are your only entry to sanctioned races! If you lose them or they are coded improperly, notify Eastern immediately for replacement/correction. Juniors III and IV will receive 10 standard entry forms along with their competition guides.

<u>Competition Guide</u> - "Eastern Competition Program" for the current season will be sent each competitor. It will include some material set forth above plus additional material (87 pages last year) including the all important <u>Race Schedule</u> (divided by Alpine and Nordic Events) setting forth date of race, name of meet, type of event, category or class(es) eligible to participate, location of race, entry fee/deadline, who and where to send entry and fee etc. <u>Race entry deadline will be standard for all races this year</u>, i.e., entries must be <u>postmarked 6 days prior</u> to <u>meet date</u>. Again new this year <u>race cancellations/postponement information</u> we obtained by calling Ellis Ski Information Service (Direct Line into Washington - telephone 628-7840), Eastern states other than Conn. call 800/243-3520 or 3521. Racers should know the FIS Rules under which they will be racing. Rule books may be obtained from Eastern, or USSA for \$3.50.
