## DIRECTIONS TO THE YESSLER HOME FOR THE MARCH MEETING:

From Beltway, take Exit 31 B (south) - Georgia Avenue; Silver Spring. Go past three traffic lights the first two are VERY close together) and turn left on Grace Church Road ( 0.6 miles from Beltway exit). Go one block on Grace Church Rd. to Woodland Drive and turn right. The house - 9107 woodland Drive - is the 2nd house on the left side - white brick with biue frame trim.

From D.C., get to 16 th street N.W. going north into Maryland. Go on 16 th Street extended 1.0 mile from the District Line where l6th Street dead-ends into Georgia Avenue (Silver Spring). Turn right (south) on Georgia and get immediately in the far left lane and turn left at the first left possible - Grace Church Road Conly 0.1 mile from where l6th street ends on Georgia). Then proceed as above.

PASTEVENTS
SUN VALIEY is a place of spectacular beauty, the locals are congenial, and the skiing is awesome. For most, the trip to Sun Valley was a first and a most memorable one. For a few the trip was a mixed experience.

Prior to our arrival, about 14 inches of snow descended on Sun Valley and the surrounding area. This snow storm closed the small Haley airport outside Sun Valley and created slippery, treacherous highways leading into the resort. Several PVSers (Joan and Glade Flake, Dina Taylor, Tony Drago, and Margaret Campbell, scheduled to fly into Haley, had to make alternate transportation arrangements. They arrived in Sun Valley late Saturday evening; their ski equipnent and clothing arrived about two days later.

We stood in line on the first day of skiing for over an hour due to snowboarders who sneaked onto the slopes before the opening time to catch the first powder. Their presence prevented the avalanche shooting until the ski patrol could get them off the slopes. Many stopped skiing early because of the deep power and steady downstream of snow. These conditions, however, did not deter David Abraham and Reg Heitchue (although a PVSer, Reg was traveling and bunking with his Reston neighbors who have formed a ski group known as the Slope Dusters). David and Reg skied the black bowls daily.
Some mishaps occurred during the trip. Glade Flake tripped over a bag in the lodge lobby and advertised a shiny bump on his head and a deep gash on his arm. He was ushered to the local medical center where the doctor administered a tetanus shot and promptly dismissed him.

Liz Triau, PVS Ciub's 'First Lady' broke her leg in two places as she was getting off a chairlift. She was immediately rushed to the medical center where she competed for attention with Sandra Day o'Connor, also seeking medical treatment for a ski injury.

Serge Triau, the ONLY PVSer who competed in the Prime Time NASTAR races, received a silver medal and a lovely pair of pink sunglasses which Liz promptly confiscated. Liz said they looked better on her and pink was not Serge's best color.

Although most PVSers live to ski, many were seen off the slopes enjoying other activities. Marilyn and Dick Clark went to the Opera House where they saw the classic movie, Sun Valley Serenade. Bill Anderson, June Kelsey, and Charlie Gordon visited the Ketchum Historical Museum where they sat in a chair from the world's first chairlift. Pat Summers, Al Richman, Ruth Schrider, Bette Walker, Emmi Plowman, and Marion Webb enjoyed a skating lesson. Lu Beale's nephew, who owns a ranch near Ketchum, treated her to dinner one evening. Some PVSers allege she helped her nephew rustle cattle; but the same PVSers could not verify if she helped shovel out the barn.
Kudos to Jack Peoples and Myron Marguardt (Assistant Trip Leader) for putting together a fabulous ski trip. And special acknowledgment and appreciation to Rachel Abraham who was the 'unofficial' hostess who did the most at the evenings' apres ski parties in the condo they shared with Jack.

## CAPONATA

Parboil 1 medium eggplant for 10 minutes. Cool. Peel. Cut into 1 -inch cubes. Lightly salt and drain in colander.

Blanch 2 tomatoes and peel. Remove seeds.
Chop and reserve. (May use 1 can tomatoes - drained.)

Heat $1 / 4$ cup olive oil. Saute for 10 minutes -1 large stalk celery, finely chopped Add and saute for 10 minutes more;

- $1 / 2$ cup chopped onion

Remove vegetables from pan and set aside. Add to pan and heat:

- $1 / 4$ cup olive oil

Saute drained eggplant until golden brown.
Add reserved onion, celery, and tomatoes,
Add 1 teaspoon sugar and cook for 5 min . Add:

- 2 Tablespoons chopped parsley
- 6 green olives, sliced
- 1 Tablespoon capers
-2 teaspoons anchovy paste mixed with $1 / 2$ cup water
- Salt and pepper - to taste

Cook uncovered about 20 minutes or until thick. Serve chilled or at room temperature with pita bread or crackers.

## DATE CAKE

Mix one 8 oz . package chopped dates with $11 / 4$ cups hot water and set aside.

Mix together:

- 1 cup sugar
-1 teaspoon baking soda
- 2 Tablespoons cocoa
$-11 / 2$ cups flour
- dash salt

To the above mixture, add and mix well:

- $3 / 4$ cup vegetable oil
-2 eggs
- dates with water in which they soaked

Grease 9" X 12 " pan and dust with cocoa.
Pout mixture into pan. Sprinkle top with:

- 16 -oz. package chocolate chips
$-1 / 2$ cup sugar
- $1 / 2$ cup chopped pecans

Bake at $350^{\circ}$ for 30 to 35 minutes.

## LEMON SPICEBARS

Stir together well:
-1 cup all-purpose flour

- 1 teaspoon baking powder
$-1 / 4$ teaspoon ground cinnamon
$-1 / 4$ teaspoon ground nutmeg
-1 cup quick cooking oats (uncooked)
$-11 / 3$ cups packed brown sugar


## Add:

- $3 / 4$ cup vegetable oil
-2 eggs - slightly beaten
- $1 / 2$ cup chopped pecans
- 2 teaspoons lemon juice
$-1 / 2$ teaspoon vanilla extract
Spoon batter into a greased and floured $13^{\prime \prime} \times 9$ " X 2 " pan. Bake at $350^{\circ}$ for
25 minutes. Spread glaze over top while hot. Let cool and cut into 2" X 1" bars.
Makes about 5 dozen.


## LEMON GLAZE

Combine all ingredients, mixing smooth:
-2 cups powdered sugar

- 1 Tablespoon lemon juice
- 1/4 teaspoon cinnamon
- 3 Tablespoons milk
