We have just completed three successful trips for 2009. Our goal now is to get proposals for the 2010 season. We need the full proposals by **April 15**, but would like to hear from people before then with ideas and short proposals. We urge you to come forward with your ideas and questions. In accordance with the **Guidelines for a PVS-Endorsed Ski Trip** (the **Guidelines**), the STC is issuing this "Preliminary Call for 2009-2010 **Winter** Ski Trip Proposals." (The STC also will accept preliminary proposals for **Summer** 2010 trips at the same time.) Preliminary ski trip proposals should include, at a minimum, the proposed destination, dates, and hotel location (ski-out/ski-in or not) for the ski trip. If even "guess-timated" costs are available, that information will be considered favorably by the STC.

For planning purposes, potential Ski Trip Leaders (STLs) should be aware of the following:

- One firm proposal for the 2009-2010 ski season has been received by the STC already, and has been approved by the ExCom – a return trip to Snowmass, CO in Jan. 13-20, 2010.
- There are two planned Blue Ridge Ski Council (BRSC)-sponsored ski trips planned in 2010:
  - The annual BRSC Western Carnival at Heavenly (Lake Tahoe), CA from February 20-27, 2010;
  - The BRSC 2010 EuroFest scheduled in Bormeo, Italy March 6-14 2010; probably with both pre- and post-skiing extensions.

January 13, 1995 -- March 15, 2009

Josie, a miniature dachshund, was a frequent participant in PVS activities, but never a full member -- she couldn't pass the ski test. For 14 years, she was a dedicated and devoted pal of Lu Beale and then, Mary Beale. During her younger years she took hikes with Lu - lots of them. We recall hiking the Capital Crescent Trail near Bethesda, as well as around Seneca Lake, the Great Falls area, and Sugarloaf Mountain. Josie would toddle along as best she could with her short legs and then Lu, or one of us, would carry her. In her later years, she didn't do hikes, but did do laps (as in sitting on them). We recall the time that four of us were at Lu's house for lunch. We all had a turn holding Josie on our laps.

Josie often attended PVS events, such as Oktoberfest, and Fall Foliage Weekends at Blue Knob. She loved being a hound and sniffing out the chipmunks in the woodpile. Got lost once, chasing one 'munk trail after another.

Mary said that her life soon became intertwined with Josie's daily To-Do list. Josie's favorite pastime was digging in the ivy in the back yard. She gave commands throughout the day, usually by shaking herself to make the quietest noise or by gesturing her head when she had your attention. She lived for the mailman's regular delivery and attacked the mail as it rained through the slot. She didn't rest until she had confirmed that the mail truck was out of sight. Then her work for the day was complete.

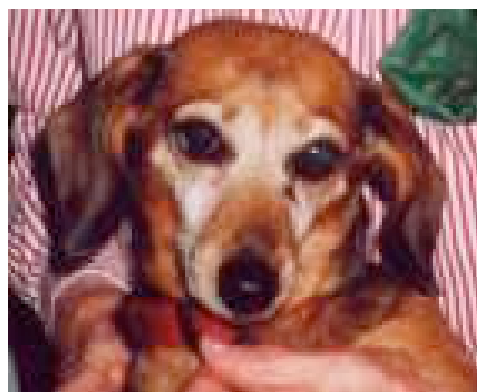

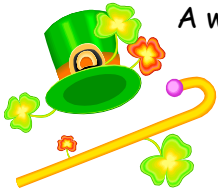
Marty is home from the hospital following complications from her chemotherapy. Bob says recovery is slow but she is doing OK.

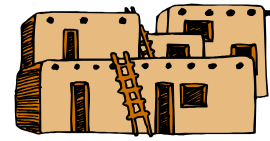

## TAOS, NEW MEXICO 2009 TRIP



Friday, March 13 marked the beginning of the Taos, New Mexico ski trip for an adventurous group of PVSers (Melissa Fitzgerald, Reg Heitchue, Cara and Bob Jablon, Joe Jevcak, Bob Knopes, Dick Laeser, Susan and David Payne, Shirley Rettig and her niece Beverly Rettig, Marty Rine, Rosemary and Dick Schwartzbard, Eloise Strand, Jean van der Tak, Dottie Villers, Liz Warren-Boulton, Liz's son Geoffrey Warren-Boulton, and Kelly Wolsayer and Ray Rosenbloom (residents of Columbia, Maryland, who found us on the internet – they were a great addition to our group – we hope they will become members of PVS and join us on future ski trips).

Fortunately, all went well on the flight to the “Land of Enchantment”. Our leaders, Liz and Joe, Gold Class American Airlines fliers, were able to get our bags on without a fee, the flights were on time, and we had a pleasant bus trip from Albuquerque to Santa Fe. The unique architecture and culture of New Mexico were readily apparent on our arrival at the airport terminal – a building designed to reflect the adobe, pueblo style prevalent in New Mexico. Unique features of the airport terminal include a beautiful wooden Spanish style ceiling in the main room of the terminal, walls painted in sand and turquoise colors, and large clay Native American pottery lining the airport access road.



After an hour's bus drive through the semi-arid, hilly, sagebrush-covered New Mexican landscape, we arrived Friday afternoon at the beautiful, historic La Fonda hotel, right off the central Plaza in Santa Fe. The large spacious rooms and public spaces of the hotel are filled with paintings, painted furniture, murals, carvings, wood work, and light fixtures by New Mexican artists. Members of the group dispersed to enjoy the many museums, galleries, shops, and

restaurants of Santa Fe (highly recommended restaurants include the Coyote Café and the Pink Adobe). On Saturday morning, many in our group had breakfast at the memorable Café Pasqual (displaying wall murals, and ceiling hangings of clothing and lacy objects), and enjoyed huge portions of breakfast burritos, huevos rancheros and southwestern style omelets. Saturday afternoon, we headed off to Taos, courtesy of the Inn at Snakedance, which provided the van service from Santa Fe to Taos. Our two hour drive through the town of Taos to the Taos Ski Valley, 25 miles from the town, took us through much spectacular mountain scenery.

The base elevation of the Taos Ski Valley is 9,207 feet (with the top of the highest lift at 11,819 feet), and the ski mountain is one of the steepest in North America. On arriving at the ski resort, the visitor is greeted by a view of two steep bump runs and a sign that states: “Don't panic. You are looking at only 1/30 of Taos Ski Valley. There are many easy runs too.” Our intrepid group settled in right away, and enjoyed a welcoming cocktail party, where the manager of the hotel presented Liz and Joe with a book about the history of Taos and each member of the group received a black vest emblazoned with the logos of the hotel and PVS. A little about the history – Taos Ski Valley was started in 1955 by Ernie Blake, a determined, “personality plus” character of German/Swiss/Jewish origin, who emigrated to the U.S. prior to World War II, and served in a U.S. intelligence unit during the war. After the war, he worked at a number of Western ski areas, and then brought his wife and children to the wilderness to

build the Taos ski area. The ski area is still owned by the Blake family, and many of the runs are named after the early pioneers who worked with Ernie Blake in developing the resort.

On Sunday, a warm and sunny day, most of the group headed off for the first lesson of our ski week. Taos gets top ranking for its ski school, and the area prides itself on being in the forefront in developing ski technique. We self-divided ourselves into “aggressive” and “non-aggressive” skiers, and then faced a ski-off, in which we were grouped with like skiers. Our leader Liz, her son Geoffrey, and Kelly were in the top “10” group, which, over the course of the week, hiked to the top of the mountain numerous times and skied the double black diamond cliffs: “WOW.” The rest of us mere mortals did not attempt such feats, but unquestionably stretched our abilities on the challenging runs of Taos.



The weather continued warm and sunny over the course of the week, with only a smattering of snow one night early in the week. Towards the end of the week, the runs tended to be crusty in the morning, and slushy in the afternoon. Not the best snow, but, on the other hand, we weren't cold, and we came back bronzed from the sun. Further, most of the members of our group enjoyed the ski lessons, and improved their skiing skills. Kudos, in particular, to Joe for following his instructor down a slope that the instructor determined was too steep and icy (even though the instructor tried to wave to the group to go the easier way) – Joe successfully navigated the slope, while the instructor fell. Rosemary was very pleased that she had made nice turns on the steep bump run, “Blitz” and experienced some challenging tree runs. Quite remarkably, despite the crowds (it was spring break for Texas) and the massive dodging of the many snowplowing Texans and the snowboarders (allowed for the first time this year at Taos), there were no ski injuries on the trip.



There were many opportunities for group interactions. Because the inn offered two-bedroom condos, rather than individual rooms, three or four skiers shared each unit. The condos were spacious and very attractive with sand-colored tile bathrooms, teak kitchen cabinets, black granite kitchen counters, and dark wood furniture. Liz and Joe arranged meeting places for lunch each ski day, and held a number of PVS après-ski cocktail parties. A highlight was our St. Patrick's Day party, where the prize (a cup with a shamrock design) for the best outfit went to Dick Laeser, who paraded around in green Guinness pajama bottoms, a green and white checked shirt and a green hat. Melissa and Kelly also won prizes for their outfits. Every morning, we had a breakfast buffet at the Inn, with a different hot offering each day, except for Monday morning because there was no electricity for several hours in the entire ski valley (apparently a bird hit a power supply box and shorted the transformer).

We also had a number of group dinners, including a four course dinner at the Inn at Snakedance restaurant. Our most memorable dinner was on Monday night at the home of the manager of the hotel and his wife (Roger and Diane), who live in a beautiful contemporary high-ceiling adobe home on the outskirts of the town of Taos. After a pre-dinner stop to see the spectacular Rio Grande Gorge and bridge, Roger and Diane treated us to margaritas, wine, appetizers, and a dinner of pork with raspberry sauce, shrimp, thin spaghetti, and a vegetable medley of peppers and squash. At the dinner, we had the opportunity to speak with the charming and knowledgeable son-in-law of Ernie Blake, Chris Stagg, who is involved in the management of the ski resort.



Another excellent dinner was at a restaurant in the town of Taos – Graham’s Grill – where most members of the group went after an afternoon excursion to town on Wednesday. In Taos, we explored some of the Taos Art Museums, notably the Harwood Museum of Art and the Fechin House, both of which have collections of the original Taos Society of Artists as well as later works by New Mexico artists. Taos also provided an additional opportunity for shopping for paintings, craft items, and fun and funky clothing. Rosemary, Cara, and Eloise found some great bargains at a little clothing store called “The Spotted Bear.” Shirley was successful in finding items with kokopelli designs for



her sister; Beverly bought a beautiful watch; Rosemary found a stunning silver belt; Dick purchased a wool jacket that met his wife’s specifications; and, Cara and Bob added to their collection of folk art. Prior to dinner, many members of the group enjoyed cocktails at the Adobe Bar at the historic Taos Inn.

Other evenings, some members of the group took advantage of the condo kitchens to cook dinner, while others tried the restaurants in the ski area. One night, Dick Laeser had the pleasure of being the only man wined and dined by a group of seven women at a pot luck dinner. Several evenings, members of the group enjoyed the live music at the St. Bernard, the inn up the hill from our hotel. The St. Bernard, a rustic wooden structure, is owned by Jean Mayer, the head of the ski school, and an old-timer who worked with Ernie Blake.



The last day of ski lessons, the groups participated in the Taos Martini Tree tradition, enjoying sips from a martini flask hidden behind marked trees. The story is that Ernie Blake once took four women non-skiers up the then rope tow, which crossed an expert slope, on the way to the beginner’s run. The women fell off and could not get back on the rope tow. Ernie directed that a pitcher of martinis be brought up, instructed the women to drink the martinis (“drink or die”), and coaxed them down the expert hill.

Saturday morning, we boarded the Inn’s vans for our trip back to the Albuquerque airport. Although the timing was a little tight, we, and our luggage, all made the flight for an on-time arrival back in DC. If only the ski season were not over, and we could practice all that we learned at Taos before waiting until next winter.

I have been most impressed with how PVSers have jumped in to fill the gap so Toot could continue its important role.
