DIRECTIONS TO SCHARTZBARD'S.

FROM LEE HIGHWAY: Heading toward Rosslyn, turn right at Quinn St. (at Colony House Furniture Store). Turn at the first left onto Key Blvd. Turn left at Ode St. Turn right at Colonial Terrace.

FROM I-66: Heading east, take exit 73, Rosslyn/Key Bridge, onto Lee Highway. Follow Lee Highway directions above.

FROM ROUTE 50: Heading either east or west, take the Rosslyn Key Bridge exit. This puts you onto Lynn St. Turn left at 19th St. (just after McDonalds). As 19th St. curves to the left and you go up the hill, turn right at Key Blvd. Turn right at Ode St. Turn right at Colonial Terrace.

FROM G.W. PARKWAY HEADING NORTH: Exit onto Rt. 50, just before Memorial Bridge. Follow Rt. 50 directions above.

FROM G.W. PARKWAY HEADING SOUTH: Take the Roosevelt Bridge exit. As the ramp curves to the left, take the Rosslyn/Key Bridge exit, which is a ramp on the right (and not well marked). This puts you on Rt. 50. Follow Rt. 50 directions above.

FROM KEY BRIDGE: Key Bridge leads onto Ft. Myer Dr. Turn right at 19th St. (at the Best Western Hotel). Turn right at Key Blvd. Turn right at Ode St. Turn right at Colonial Terrace.

Parking is extremely limited.

Thanks to those who submitted names for consideration by the committee. There were 20 good candidates from which to choose which demonstrates that we continue to be a strong club.

Report on Ski Trip Committee Meeting with Potential Trip Leaders We want your input NOW.

Even though many have yet to put on skis for this season, the PVS Ski Trip Committee (STC) is already looking ahead for the 2003/2004 ski season. Members Barbara Leonhardt, Bob Marx, Jim Slack, and Mike Hatanaka (member Eloise Strand was off skiing) met January 6 with PVS'ers who were interested in leading a ski trip in 2004 or beyond. Eleven additional PVS members joined the meeting to talk about trips for the 2003/2004 ski season. **The time frame for proposing to lead a ski trip for the 03/04 ski season is Jan. 15-Mar. 15, 2003** (see information below). **It is important for PVS members to provide input NOW to the trip leaders and to the STC members on the prospective trips that were discussed** (see below). Much work is required to plan a ski trip and the trip leaders want some assurance that there is sufficient interest. **So please call the trip leaders or an STC member.**

Thus far we have no trip proposals for a December 2003 trip. Sally Finan and David Lerner are considering leading a trip to Steamboat (the Sheraton of course) mid-late Jan. 2004. Ray and Nancy McKinley are looking into a Feb. 2004 ski/sightseeing trip to the 6,000 acre, 4,300' vert. Sierra Nevada ski area near Granada, Spain (potential host for the 2010 Winter Olympics). This could be followed by an add-on to Spain's sunny, Mediterranean, Costa del Sol with tours to Gibraltar and Morocco-and perhaps even skiing in Morocco's Atlas Mountains. Alternatively, they are looking at Big Sky, MT, probably in March, staying at the new hotel at the base of the mountain. **They would love to hear from you if you have interest in either venue.** The 2004 BRSC trips are to Snowmass in late January or early February and to Cortina, Italy with side trips (possibly to Venice) in early March. Unfortunately, the dates and trip details will not be available from BRSC until perhaps March which makes it difficult to plan PVS trips to avoid conflicts. However, if you are interested in one or both of these BRSC trips, please let a member of the STC know.

Calling for Proposals for Trips for 2003/2004 Ski Season **Due January 15 – March 15, 2003**

Although the 2003 ski season has not yet begun for some in PVS, the time period for prospective trip leaders to submit trip proposals for the 2003/2004 season to the PVS Ski Trip Committee (STC) already is nearly half over – proposals are due between January 15 and March 15. This period is the same for trips originated by PVS members as well as trips run by the BRSC with PVS leaders for a PVS contingent. The *PVS Ski Trip Guidelines* have been revised and are available on the PVS web site or can be requested from Barbara Leonhardt; all prospective trip leaders should become familiar with these guidelines. **The STC requests that the following information be included in the ski trip proposals:**

- Destination
- Preferred dates
- Identity of trip leaders; please provide a short statement of qualifications for running a trip.
- Best indication of price
- Maximum number of participants planned
- Details about the trip as available, e.g. lodging choice (ski in/ski out?), any optional activities or add-ons, and name of tour operator if known.

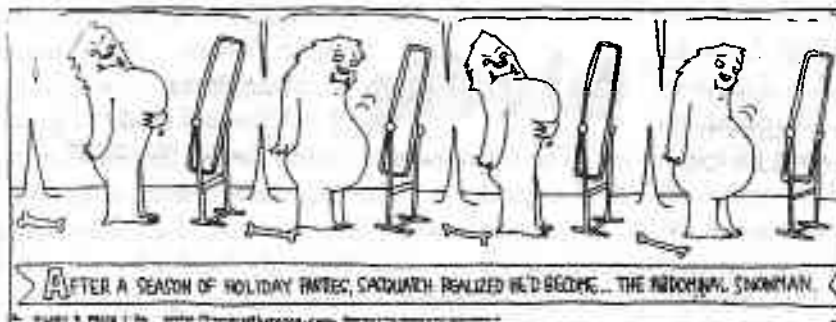

So much happened—please talk to the Snowmass group to hear of other adventures. Suffice it to say each one was grateful to Barbara for her superb planning and leadership!!

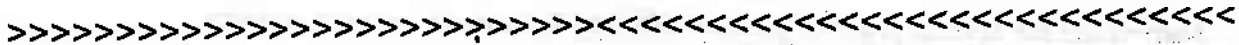

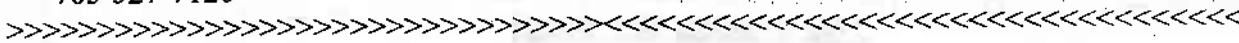

Ski souvenir: GPS map of your day on the slopes. SlopeTracker is a GPS tracking system currently available at Keystone, Colorado. Skiers attach the GPS to their arm at the beginning of their skiing day, do their thing, and return it at days end. For \$24.99 they receive a full color 3-D look map of their path, along with statistics about their efforts compared to others on the mountain. The custom souvenir has been available for just a few weeks, but looks like a hit.
