## President's Message

### SKIING AND FOOD

Persuading others to act positively – that is, to act as you want them to - is a most difficult task. One tried and true method is bribery. See [Jerry Bock](#), *Fiorello: A Little Tin Box*, reporting on Tammany Hall's getting its members to save money by having them place donations into tin boxes. As I have relayed previously, I grew up in an environment where people did not purposely attach boards to their feet to go down snow laden, or worse rock laden, slopes. Cara bribed me to ski by offering savory meals at restaurants close to nearby ski mountains.

Cara began by taking me skiing near Manchester, Vermont, at Stratton Mountain. Even after I discovered that the only way I knew to stop was by falling, Cara found a way to get me to return, using the enticement of a striking, purple, Manchester restaurant called the *Reluctant Panther*. When she took me there after my first day of skiing at Stratton, having just gotten off the slopes, we were dressed – a mess.

A young wisp of a girl, the daughter of the owners answered the door, maybe she was twelve. I said that we had three questions: could the restaurant take us for dinner as we were, could it take us now (we had to drive back to Albany, New York) and could it take a check (this was before the common use of credit cards). She responded yes to one and three, but she had to check on two. We waited for her answer with anticipation. She said, "Yes." We had the best gourmet meal that I had ever had.

The restaurant, off the main street in Manchester, was and remained a gem. But after the owners' daughter grew up and the owners, the Cornells sold the restaurant, the restaurant remained good, but it became less special. Looking at Open Table now, with a more recent chef, the *Reluctant Panther* looks as if it has reverted to being different, unique and gourmet. It states that it serves fresh local food to those who will wait for the panther, who, legend has it, is reluctant to come down from the mountain to meet people, but does so when given sufficient incentives. Those going to Mount Snow or Southern Vermont may want to give the *Reluctant Panther* a try.

Another strong Vermont recommendation is the *Chanticleer* in East Dorset. If you have to wait, a quintessential Vermont doll house and toy store is nearby. The *Chanticleer* has the feel of a classic Vermont restaurant. It serves hard to find, old fashioned, plentiful Duck à l'Orange and mouthwatering rack of lamb. Again, if you are going to Mount Snow (or even Bethesda, but the drive would be longer), the *Chanticleer* is worth a trip.

Many are going to Snowmass. The *Little Mammoth Steak House*, up the stairs from the Snowmass Chalet at the end of the mall, has large, succulent steaks. You've been skiing. You deserve it. Although the steaks are truly excellent, one of our members was turned off by the restaurant's having cooled red wine, but you can't have everything. The *Little Mammoth* is a treat.

*Il Poggio*, an Italian restaurant behind the mall, is also very good. The fish is recommended. *Venga Venga* also just up the stairs from the hotel (conveniently past the infirmary) is informal and good. Cara attests the quality of the Margaritas (that is a plural). I recommend the Carne Asada.

In Aspen at the *J-Bar* at the *Hotel Jerome*, one gets history plus a good lunch – well worthwhile.

I know nothing other than TripAdvisor about Big Sky Restaurants, but if you are in Taos, do arrange to eat at the *Hotel St Bernard* at the base of the mountain. The meals are preset, planned by the owner and chef each night, and outstanding. They are worth it. You get not only dinner, but also history from contemporaries of the mountain's founders. Bookings in advance or great charm (*i.e.*, hanging around and judiciously pleading for an opening) are

necessary to get in because tables are reserved first for hotel guests. Lunches are also recommended during which you can plead to get in for dinner.

When getting to Taos through Santa Fe go to the *Coyote Café*. The restaurant is downtown near the Plaza. Founded by Mark Miller, formerly of the *Red Sage* in D.C., the *Coyote Café* is one of the best restaurants, anywhere.

At Park City, you cannot beat *Chimayo*, uniquely Southwestern and very good. Also, *Yuki Yama*, a Japanese restaurant, as I remember and the reviews attest, is well recommended. Unfortunately, Robert Redford's Zoom has closed. You need to get to special restaurants when you can.

In Steamboat Springs, just off the slopes, *Café Diva* is very, very special serving French, gourmet food. And every once in a while when you get there late, a wine seller is promoting wines and offering wine tastings to those at neighboring tables. We have been so advantaged.

I close on Pittsburgh. If you take John Smith up on his extended multi-day ski options, the best steak I have had may have been at *Meat and Potatoes*; the best Seafood combination is at *Eleven*. Pittsburgh restaurants are a good incentive to go to Seven Springs for skiing or just to visit Pittsburgh.

That is all for now. Other free recommendations for restaurants near ski areas will be supplied on request.

### Addendum to President's Message – Local Activities and Events

Any who have suggestions for events and trips that they want (or are willing) to lead should please inform any member of ExCom, who will then also inform the Events and Meetings co-chairs. If a proposal is approved as an appropriate PVS event, we shall publicize it in the TOOT, if there is time, or by email. Of course, nothing prevents club members from jointly participating in events, but where it is desired to have an event open to all club members, subject to space limitations, we would be pleased to facilitate communications among club members.

## IN MEMORIAM GERDA M. PICCO

Gerda Picco, a four-year member of Potomac Valley Skiers and long-time member before then of Capital Golden Skiers, died peacefully at her home surrounded by family on October 4, 2017. She suffered for a short time with pancreatic cancer.

Gerda was a founding member of Capital Golden Skiers and hosted meetings at her home. She also hosted bridge there once a month until chronic back pain forced her to cancel. She insisted that it was not the members who were “a pain in the back.” Gerda also joined a number of ski trips out West with the club. Her warmth, hospitality, generosity, and good cheer were appreciated by all.

Gerda was born in Cleveland, Ohio, and came to Washington DC after graduating from college and never left. Her career included working as a mathematician for the Propulsion and Power Division of the Naval Air Systems Command. She was a pioneer in the formulation and use of computational methods in the design, development, and performance prediction of the engines in our modern-day turbine powered aircraft. She was also active in many organizations -- her garden club, the Widowed Persons Group, the ski club, and her golf group. She was a devoted member of The United Church, made desserts for the annual fall sale, and was the coordinator for the Trichur Project in India.

She married John Picco in 1971. John died in 1991. She is survived by a brother, sister, several nieces and nephews, and a family of grandchildren, great grand-children and great, great grand-children!

A number of ski club friends (Inge Lesjak, Paul Levy, Don Vierimaa, Blanca Hotaling, Bob Kramer, John and Gisela Storm) shared memories of her time with both clubs and as her friends. The following is a compilation of some of their comments:

Gerda provided her home for Board meetings of the Capital Golden Skiers and for bridge nights, providing coffee, tea and snacks (and, sometimes “two buck chuck” wine!). She always had a smiling face and warm, personal greeting for everyone. Her house was always neat, clean and decorated with fine taste. She was someone who could make anyone comfortable. Although we knew she suffered from back problems, she did not complain nor did it affect her smile. She never spoke an unkind word about anyone. She was quiet, elegant, did everything well, and was just plain nice, a true lady. She will be missed by all who knew her and will remain in our hearts forever.



After the show those who are interested may join us for a late lunch/early supper at a nearby restaurant.


Tickets are \$54 per person, non-refundable group rate.

During ski seasons, we currently have and are continuing a program of daily, local ski trips. ### PROPOSAL FOR SKI TRIP TO MT. SNOW, VERMONT

March 18-24, 2018

*If interested, please let us know by the end of November*



This is an opportunity to ski at Mt. Snow, Vermont, with Alice McNulty and Dick Lau who have been skiing there for years. This is a beautiful mountain with a total acreage of 589. The base elevation is 1,900 feet; with a summit elevation of 3,600 feet; and vertical drop of 1,700 feet. There are twenty lifts and tree terrain available on all four mountain faces. The percentage of terrain for different abilities is: 14% green, 73% blue and 13% black.

**HOTEL:** We would stay at the ski-in/out **Grand Summit Hotel**. It has an exercise room, pool and spa.

**LIFT TICKETS:** Senior 4-day midweek \$140; senior 5-day midweek \$170. People might want to get the 4-day and ski at Stratton Mountain one day. It's about a 45-minute drive.

**PROPOSED DATES:** Proposed dates March 18-24 to provide 5 full days of skiing.

**TRAVEL FROM DC:** Air: Flights from Dulles to Hartford on United are 1.5 hours and are \$199-\$169 depending on whether you fly Sunday or Monday.

Transportation to the resort from Bradley Airport (Hartford) to Mount Snow is provided by Thomas Transportation in a private van for about \$41-\$46/per person depending on whether we would need a trailer for skis and baggage.

**ESTIMATED COST:** The **estimated** cost would be approximately \$900:

Airfare \$200

Airport transfer \$84.

Room approximately \$400 (per person/shared).

Senior midweek lift ticket (5 days) \$170.

No meals included but we will try to set up a welcome wine and cheese party. We will also check with the hotel (or other local restaurants) for a farewell dinner and the cost.

*I have been skiing at Mount Snow for almost 25 years. It really has something for everyone in terms of terrain, and each year the snowmaking gets better and better - so there are virtually no gaps. Dick Lau and I would be happy to ski with anyone and show you the mountain. West Dover and Wilmington are charming, postcard VT towns with some excellent restaurants. There is also the possibility of a moonlight sleigh ride (weather permitting), snowmobiling, snowshoeing, and cross-country skiing.*
