

MOST POPULAR SKI RESORTS IN THE WORLD:

PlanetSki reports that the 2014 International Report on Snow and Mountain Tourism rates the world's most popular ski resorts based on their number of skier

days. The report is in its 6th edition and covers the snow sports world of 56 countries representing 99.6% of the total market volume. Listed below are the top resorts:

- 1. La Plagne (France)
- 2. Saalbach Hinterglemm/Leogang (Austria)
- 3. SkiWelt Wilder Kaiser (Austria)
- 4. Les Arcs (France)
- 5. Ischgl/Samnaun/Silvretta (Austria)

- 7. Courchevel, Méribel, Mottaret (Les Trois Vallées, France)
- 8. Val Thorens (France)
- 9. Vail (Colorado, USA)

Other U.S. resorts in the Top 50 were Mammoth (32), Keystone (43), and Copper Mountain (44). The study also stated that 48% of the world's resorts are in Europe, 35% in the Alps, 21% in the Americas, and 13% in the Pyrenees -- and there are 48 resorts in the world that have more than one million skier days each, three-quarters of which are in the Alps.

You will note that Zillertal/Mayrhofen is in 14th place. It could be said that Inge is running world-class ski trips. Last year she led a trip to Vail, which is in 9th place. Andorra made 20th place so the McKinleys also lead popular trips. I have skied at about 8 of the top 20 and plan to add more to my list. However, there is a lot to be said for the less popular areas such as Snowmass where you don't have to worry about fighting crowds and waiting in long lift lines!

PVS/BRSC SKIING AND SIGHTSEEING ADVENTURE MT. BACHELOR AND BEND, OREGON JANUARY 31-FEBRUARY 7, 2015

Mt. Bachelor is the largest ski area in central Oregon, with terrain for all levels. The mountain is an extinct volcano, and you can ski with full lift service 360 degrees off the top for 3,365 vertical feet to the base, often through light, dry powder! It has the highest skiable elevation of any resort in Oregon or Washington and is far enough inland for drier snow conditions. The resort gets an average of 462 inches of snow a year on 88 runs, served by 10 lifts. (Mt. Bachelor is adding over 400 acres of ski terrain that is scheduled for opening in 2015). In addition, the resort has more than a dozen cross-country trails, 35 miles of which are groomed. The mountain grooms 40 of the 88 runs. Volunteer Mountain Hosts will ski with you all or part of the day, at your request.



The mountain is a 30-minute bus ride from Bend where you will be staying in the newly upgraded Double Tree Hotel. There is an indoor pool and hot tub. You can walk to the historic downtown district of Bend with lots of shops and restaurants. Buses will pick you up at the hotel and take you directly to the mountain where you will store your skis. No long walks are involved. Non-skiers will have options to go to Crater Lake, the town of Three Sisters, wine tasting, dog sledding, snowshoeing and more. Included in this package are:

And we are now on the slippery slope towards our favorite season—ski season. Whooopppee!

The states with more skier days than Vermont are Utah and, of course, Louisiana.

Bill and Bonnie Sweeney stopped by the DC area whilst continuing their multi-year odyssey to motorboat completely around the Eastern US. (They leave their boat at a marina over winter.) Citing the New York Times, <u>Marvin Hass</u> noted that the beer will flow at the Snowbird Oktoberfest after the state liquor board backed off its warning that the long-running German celebration could go dry this year.

Utah's state liquor board just voted unanimously to grant a license for Snowbird Ski Resort's 12-week event, now in its fourth decade. Resort managers say next to a fresh batch of snow, Oktoberfest, which begins Aug 16, is a big draw bringing in 60,000 people.

The state relaxed its heavy-handed liquor laws in 2009, when it stopped requiring bars to operate as members-only social clubs.

The Snowmass Mountain Chalet is an independent lodge, managed on site, with easy access to the slopes. Each of the 64 rooms has either 2 queen beds or 1 king bed, depending on availability. All rooms have: hair dryer, TV, small refrigerator, etc. The lodge has a nice lounge on the main floor with chairs, game tables, fireplace, and large windows overlooking the slopes. There is an elevator, exercise room, outdoor pool, hot tub and laundry facilities. A full breakfast is served family style each morning. A complimentary soup lunch is served from Noon to 1:30 PM. The lodge has no restaurant for dinner. However, the Snowmass Mall, on the level above, has many restaurants of all price levels. One can walk up some stairs or use the elevator at the end of the mall. Bus service stops are nearby for trips to a nearby grocery store, into the town of Aspen, to other Aspen ski areas, and to Glenwood Springs.

Trip Insurance

Trip insurance is recommended. Travel Guard is available through our travel agent, Encompasse Tours at **Encompasse.com**. (The insurance link will connect you to Travel Guard.) The insurance provides coverage for accident, illness, injury, or death to attendee or immediate family member and will refund all expenses associated with PVS Snowmass 2015 in these circumstances alone. There are several options available, depending on your situation. Please read carefully before choosing.

Cancellation Policy and Fees

If it becomes necessary for you to cancel your trip, the trip leaders will try to minimize your losses, although some fees are mandated by the airline, hotel and tour operator. All cancellations must be in writing. **We strongly urge you to purchase trip insurance** (see above).

NOTE: Name changes and itinerary changes will incur additional fees <u>after ticketing of airline seats.</u>
Therefore, please take the time to ensure the information you provide is correct, and take note of deadline dates!

<u>Cancellation fees are as follows:</u> <u>Dates and costs are consistent with requirements and penalties imposed by vendors per contracted agreements.</u> <u>LAND</u>: \$300 after September 22 until December 1; after that, cost is entirely non-refundable. <u>AIR</u>: Tickets will be issued <u>by November 30</u>. Any cancellations after November 5 will incur a \$50 penalty. Name or itinerary changes after tickets are issued will cost: \$100 up to 8 days prior to departure; \$300 if 7 days before departure. Tickets are non-refundable and non-transferrable once issued.

<u>If you are a "single" participant</u> requesting space on a PVS-endorsed ski trip and need a roommate, we recommend each of you purchase the next level up of insurance to cover you if one of the roommates cancels. Otherwise, you will be offered the choice of one of the following three options:

- 1) Helping the trip leader find a replacement trip participant who will fill the space vacated: or
- 2) Staying on the ski trip by paying the "single supplement" or
- 3) Canceling from the ski trip and paying all currently due penalties.
