I hope that folks had an enjoyable July 4<sup>th</sup> holiday, and had the opportunity for in-person gatherings with family and friends this summer.





#### SKI TALK

## September 2021

Last September, I wrote about how we were living in unprecedented times. I truly thought by this year we would be back to "normal." Now I don't even know what normal would be. Currently we are not quarantined but Covid cases are on the rise with the new Delta variant. We still have to be careful and masks are part of our lives.

We took our first airplane trip abroad this summer to Bermuda. It was not a pleasure trip. It was an unavoidable memorial for a family member. While it went smoothly, we had to comply with all of the mandates of the Bermuda Government. We had to be tested 3-4 days before traveling; fill out a multi-page form including results of a PCR Covid test; have a vaccination certificate; supply information on how long and where we were staying, etc. Once we arrived in Bermuda, we were tested again before we could leave the airport.



Then we were quarantined in our hotel until we had the results of the Covid test from the airport (which came the next day). We had to be tested again on the  $4^{th}$  day of our trip, which meant taking a bus to the testing site and waiting in another long line. This result was sent the following day. Since we were leaving two days later, we were able to use that result to allow us to fly back to the United States.

Bermuda has strict Covid regulations. Masks are required everywhere; public transportation has every other seat blocked off. Restaurants have spaced seating. When at a restaurant you have to give contact information for Contact Tracing. I must say we did feel safe until we flew home via JFK airport in New York. The airport was crowded; few were wearing masks; and airport shuttles were packed to capacity! What a difference from the orderliness of Bermuda. Traveling is not easy.

We are happy to be planning a ski trip to Snowmass this January. We are going back to the Mountain Chalet. See the flyer in this TOOT. Aspen-Snowmass says they are following CDC guidelines and strongly encourage vaccinations for all guests. They say, "Future actions could include a reservations system, mandatory vaccinations. . ." It all worked last year so I am assuming it will be even smoother this year even if there is some social distancing required. Mask wearing is not a problem when we ski. We all wear them.



Our annual trip to Snowmass has always been popular. This year is no exception. As you know, the Mountain Chalet has new ownership. While we have been able to contract for a block of rooms, getting additional rooms is a slow process. The rooms we contracted for are filled. We have put in a request for additional rooms. We may have to start a waitlist for those of you who want to go and have not signed up yet.

John Smith has alerted me about an Epic Pass for skiers at least 80 years old. It is called 80+ Northeast Value Pass and costs \$39. It will give you unlimited skiing at Liberty and Whitetail and ten days at other Northeast resorts. It is not advertised. The only way to get it is to call the following number at Vail: 970-754-0086. There is an Epic 65+ pass for \$271 for local skiing. The best deals on the Epic Pass are the Military passes. Retired military can get a pass for \$135. Prices for the Epic passes may be going up soon. Snowmass uses the Ikon Pass. If you are 70+ and are planning on skiing eight or more days at Snowmass, the Silver Pass is your best option.

As I have said before, it is an unprecedented and unique time. Let's do our best to stay healthy, get vaccinated and enjoy what we can.

#### **Trip Details**

Once again, we will be staying at the Snowmass Mountain Chalet (SMC) which offers a convenient ski in, ski out location. Check the web-site at <a href="www.mountainchalet.com">www.mountainchalet.com</a>. The "Land Only" package includes: transportation to and from Aspen airport (7am -11pm); 5 day Senior lift pass (good for all four ski areas in the <a href="Aspen complex">Aspen complex</a>, free shuttle bus) with option for extra days; 7 nights lodging (double occupancy); daily breakfasts; soup lunches TBD; luggage handling; a welcome reception, a pizza party and a farewell group dinner to celebrate our trip. Additional nights at Snowmass are an option based on availability. Trip insurance is available through Encompasse Tours and is <a href="highly recommended">highly recommended</a>. For trail information check <a href="www.aspensnowmass.com">www.aspensnowmass.com</a>.

The basic package at \$1,925 includes a 5 day lift pass for skiers 65 and over. Skiers under 65 will have to add \$93.00.

#### **The Mountain Chalet**

The **Snowmass Mountain Chalet** is an independent lodge, managed on-site, with easy access to the slopes. Each of the 64 rooms has either 2 queen beds or 1 king bed, **depending on availability**. All rooms have: hair dryer, TV, small refrigerator, etc. The lodge has a nice lounge on the main floor with chairs, game tables, fireplace, and large windows overlooking the slopes. There is an elevator, exercise room, outdoor pool, a hot tub and laundry facilities. A full breakfast is served family style each morning. The Snowmass Mall, on the level above, and the hotel area below (via the small gondolas) have diverse restaurants at all price levels. Bus service stops are nearby for trips to a nearby grocery store, into the town of Aspen, to other Aspen ski areas, and to Glenwood Springs.

#### **Trip Insurance**

Trip insurance is highly recommended and should be purchased shortly after sending in your deposit. Travel Guard is available through our travel agent, Encompasse Tours, at Encompasse.com. Click the "TRAVEL INSURANCE" link on the grey bar at the top of the page, and register online with AIG/Travel Guard. Be sure to identify Encompasse as the booking agency at the appropriate spot on the registration form so that AIG/Travel Guard can certify the policy and interact with our vendor in the event of a claim. Please read your policy for details of coverage. If you have questions pertaining to your policy contact AIG/Travel Guard at 1.877.249.5376 (U.S. Toll Free).

#### **Cancellation Policy and Fees**

If it becomes necessary for you to cancel your trip, the trip leaders will try to minimize your losses, although some fees are mandated by the hotel and tour operator. All cancellations must be in writing. **We strongly urge you to purchase trip insurance** (see above).

Please take the time to ensure the information you provide is correct, and take note of deadline dates!

<u>Cancellation fees are as follows:</u> Dates and costs are consistent with requirements and penalties imposed by vendors per contracted agreements. <u>LAND Only Package</u>: The entire cost of the trip is non-refundable after October 15<sup>th</sup>.

<u>If you are a "single" participant</u> requesting space on a PVS-endorsed ski trip and need a roommate, we recommend each of you purchase insurance to cover both of you if one of the roommates cancels. Otherwise, you will be offered the choice of one of the following three options:

- 1) Helping the trip leader find a replacement trip participant who will fill the space vacated; or
- 2) Staying on the ski trip by paying the "single supplement" or
- 3) Canceling from the ski trip and paying all currently due penalties.

Here are the books we shared in July and August:

- Ellie Thayer has been reading "Vacationland: True Stories from Painful Beaches" by John Hodgman, a memoir about the author's life with his father which Ellie describes as "laugh out loud funny."
- Mary Ellena Ward has been reading about history in "Work A Deep History from the Stone Age to the Age of Robots" by James Suzman. The author explores the dramatic evolution of society especially with the advent of agriculture.
- Marianne Soponis explored the life of Coco Chanel through "The Queen of Paris" by Pamela Binnings Ewen. Though fictionalized, Ewen relates the true story of Chanel's difficult upbringing and her time during WWII.
- Bonnie Sweeney discussed the concepts in Isabel Wilkerson's latest book, "Caste: the Origins of Our Discontents" which finds disturbing parallels between the caste systems in India and Nazi Germany and systemic racism in the United States.
- Jan Marx read Willa Cather's "Death Comes to the Archbishop" and hardships in the 1850s American southwest. Jan also brought us "Please Don't Feed the Mayor" by Sue Pethick about the real small Oregon town with an elected dog for mayor.
- Karen Zill has been reading "Hillbilly Elegy" by J.D. Vance in which the author survived a difficult family life in poverty-stricken Appalachia.
- Nancy McKinley brought "Just Mercy" by Bryan Stevenson on efforts to free those wrongly convicted. "The Good Lord Bird" by James McBride tells of the efforts of the charismatic (and probably mad) John Brown to emancipate enslaved people.

#### In Memoriam




#### **Memories**

Ruth was our ski buddy for many years, and never missed a game night! She hosted Snowmass pre-trip parties and PVS meetings in her McLean home, as well as serving on ExCom. Ruth loved the outdoors, and she hiked with Wanderbirds (where she was treasurer for several years) and PATC. She introduced me to a group of her adventurous friends who lured us into whitewater canoeing locally and in Ontario, hiking with the British Ramblers in the Canadian Rockies, camping and biking in Vancouver and Victoria, and ecotourism in the Gobi desert and the Khan Khentii highlands



of Mongolia, with a stopover in Beijing. Ruth coined the name "Senior Moments" for the group's more modest activities during our senior years, which were organized around museum visits and lunches out. We even did some opera together. During the Covid pandemic she continued to stay in touch with us via zoom from her Lakewood residence in Richmond until shortly before her passing. #### In Memoriam



June Read, age 91, passed away on August 5, 2021 at the Shady Grove Adventist Hospital with her daughter by her side. She is survived by her daughter, Joslyn Read (married to Michel Bonard) of Potomac, Maryland; son, Russ Read (married to Beatrice McKenzie) of Springfield, Oregon; and her grandchildren, Marguerite Read and McKenzie Read. She is predeceased by her parents, Marguerite and Clarence Faber, her brothers, Cecil and Billy Faber, and by her ex-husband, Merrill "Steve" Read.

Born June Faber in Westchester, Ohio in 1929, she graduated from Ohio State in 1951 and moved to teach school at the Wasatch Academy outside of Salt Lake City until 1953. She married Steve Read in 1953, then taught in the Denver Public Schools until 1958. She developed a love of creating and surrounding herself with contemporary visual art. June began a 40-year career in real estate after moving to the Washington, DC area in 1965.

An open-hearted friend and fierce defender of those close to her, June spent her life mentoring, counseling, sheltering, and serving her family, her friends, her students, her clients, and her community. June was always ready to provide a safe refuge when things in life had just gone sideways. Her passionate creativity appeared everywhere from her early artwork to her hosting an impromptu meal for

whomever showed up in her kitchen.

June discovered skiing while living out West. Skiing and her skiing friends became the backbone of her life, giving her strength when nothing else would. After hanging up her skis at age 79, she began swimming at Asbury Center.
